# Holiday Market Details

*please read carefully*

## **Registration:**

- The market has become very popular in the last few years and we are limited for space. The gym at the Chelsea Public School is the largest public space in Chelsea and we can accommodate no more than 32 vendors.
- Space will fill on a first come/first serve basis and your application will not be considered confirmed until your registration fee has been received. The earlier you reserve and pay for your space, the more likely you are to be guaranteed a spot.
- Once we have reached capacity, your name will be added to a waitlist and you may or may not be able to get a spot.
- **Deadline for application is October 18, 2024. Spaces will be confirmed via email by October 21st.**

## **On the Day of the Event**

- Each vendor will be given a 10x10 foot space and must bring their own display materials, including a table or tables. Please plan accordingly. No tents allowed.
- The rules of the Chelsea Farmers Market apply to the Holiday Market. Please visit our website to review the rules.
- Set up will take place on Saturday morning from 7:30-8:30 am. Vendors will also have access to the gym the evening prior (Friday, November 15) from 5-7 pm for additional set up time.
- All vendors must be fully set up by 8:30 am Saturday morning to allow for “vendor shopping” from 8:30-9am.
