Registration

- This market has become very popular in the past few years and space is limited. The gym at the Chelsea School is the largest public space in Chelsea and can accommodate a maximum of 32 vendors.
- Space will fill on a first come/ first served basis. The earlier you reserve and pay for your space, the more likely you are to be guaranteed a spot. Your application will not be considered confirmed until your registration fee has been received.
- If we have already reached capacity prior to receiving your application, your name will be added to a wait list. Should any of our confirmed vendors cancel, we will offer the available spot to those on the wait list in the order in which we were contacted.
- The deadline for applications is **October 15, 2022**. Spaces will be confirmed via e-mail by October 21.

On the Day of the Event

- Each vendor will be given a 10x10 foot space. Please plan your display accordingly. No tents allowed.
- The rules of the Chelsea Farmers Market apply to the Holiday Market. Please visit our website to download and read the rules or contact us if you need a paper copy.
- Set up will take place on Friday, November 11, from 5-7pm, and again on Saturday morning from 7:30-8:30am.
- All vendors must be fully set up by 8:30am Saturday morning to allow for “vendor shopping” from 8:30-9am.
- We always strive for a festive holiday atmosphere at the event. So, please decorate your booths creatively and in that spirit.
